

Imagination Movers at Alexian Brothers 10.10.09 SWEEPSTAKES:

I. NAME OF SPONSOR(S)

Radio Disney Chicago LLC , Alexian Brothers (Hereinafter collectively referred to as "Sponsor").

II. ELIGIBILITY

Entrants must be legal residents of the 50 United States and D.C. age 16 years and younger as of entry date.
