

Oregon State Fair - VIP Suite Sweepstakes Rules

I. SPONSORS

Oregon State Fair and Radio Disney Group, LLC, licensee of Radio Disney AM1640 (hereinafter collectively referred to as Sponsor).

II. ELIGIBILITY
