

KID CURATOR SWEEPSTAKES:

I. NAME OF SPONSOR(S)

Radio Disney Chicago LLC and Museum of Science and Industry (Hereinafter collectively referred to as "Sponsors").

II. ELIGIBILITY

Entrants must be legal residents of the States of Illinois and Indiana between the ages of 7 and 12 years old at the time of entry.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Radio Disney Chicago LLC, Museum of Science and Industry, any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and/or their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. One grand prize winner will be selected at random on December 14, 2009 from the four runner-up winners. v Each winner's photo will be displayed until December 31, 2009, at the Museum of Science and Industry on the Kid Curator "Wall of Fame."  
v A one night stay for three one child and up to two adults (parent/guardian) (one room) at the Hyatt Chicago on the Friday night of the tour weekend.  
v Dinner for three at a Chicago restaurant to be determined by the Sponsors.

The private tours will be given on the following dates only: February 21, 2009; June 6, 2009; November 14, 2009 and December 12, 2009. The winner must be able to attend the tour and stay at the hotel on the scheduled dates, these prizes will not be given one any other dates. The Museum of Science and Industry and Radio Disney reserve the right to reschedule these tour dates if necessary. If dates are rescheduled revised rules with the new dates will be posted on www.radiodisney.com. The estimated retail value of the runner up prize is \$495.
